<b>Applicant</b>	<p><i>La Rondine</i> is a not for profit association created in 2000 operating in Palermo (Sicily, Italy). It has been working for years towards the direction of strengthening the power of social and educational workers and their skills in order to empower their capacity of protecting child and families. <i>La Rondine</i> moves around the child universe, above all the one of the vulnerable children. <b>Project ideas</b>	<p>The proposal moves from the desire of deepen the knowledge of praxis in the field of children rights and protection system at EU level, starting from the actual situation in Italy and trying to create a map of functioning processes.</p> <p><i>Project planning</i></p> <p>The final aims of the actual proposal can be thus resumed: <i>get children aware of their own rights; let them be better informed about the phases of proceedings and their involvement; let them be conscious of judicial proceedings</i></p> <p>Focused Actions to be improved to get the aims:</p> <ul style="list-style-type: none"> <li>0) Social survey on the different aspect of the judicial process according to culture and national differences</li> <li>1) 3 training modules destined to professionals in order to: <ul style="list-style-type: none"> <li>A) Foster cooperating skills and “equipe mindfulness”;</li> <li>B) empower knowledge on different approaches to law and practice used by different professionals;</li> <li>C) foster the use of innovative methology to face children and minors, that is theatre (dramatic methodology: theatre and role playing techniques will be used to make practical examples).</li> </ul> </li> <li>2) transnational meetings to share and compare, and to give birth to new experimentations</li> <li>3) media campaign and dissemination</li> <li>4) use of webinar or ICT in order to make distance training, and use of common platform project dedicated</li> <li>5) Creation of App and other support-tools destined to children</li> </ul> <p><b>Target</b></p> <p>Professionals from shelters and housing for children. As particular vulnerable target the project proposal is addressed to those professionals working at institutional and private field with Unaccompanied Foreign Minors, which are a strong priority actually in Italy and in Sicily itself.</p> <p>We estimate to be able to join about 100 professionals interested in participating to the training courses, and more than 200 operators engaged in knowledge and sharing procedures in a mentoring process.</p> <p><b>PROJECT LANGUAGE: ENGLISH</b></p>
